2004-2007 – assigned as an investigator to the Drug Task Force

2007-2016 – Promoted to Detective, investigating property crimes, crimes against children and major case crime –homicide, assaults etc...

2016-2019 promoted to rank of sergeant assigned to supervise a platoon of officers. 2019 – re-assigned as the departments first ever Community Outreach Sergeant. Part of the duties of the Community Outreach Sergeant is to be the eyes and ears not just for the police but for the community.
