1. Call to Order

Gene Duncan called the meeting to order at 5:30 pm.

2. Approval of the May 24, 2021 Minutes

Carole Kirchner made a motion to approve the minutes. Peter Barber seconded the motion. The motion passed.

- 3. Committee Reports
- Community Safety Safety Cameras

Dick Hecker reported that the Safety Cameras have been installed at Culliton Park. Three new cameras will be funded through SoWe funding. Dick Hecker reported out on a conversation he had with York PD to discuss a free home camera program.

• Economic Opportunity – Manor St and King St Mulching and Volunteerism Ole Hongvanthong stated that committee members along with SoWe Clean Crew and Bicycle Ambassadors mulched the tree wells of W. King and Manor St. The activity was a great way to engage neighbors. Mr. Hongvanthong encouraged board members to volunteer and organize similar events.

The board discussed a condemned building at the corner of New Dorwart and Manor St. The condemnation was a result of a fire. SoWe staff connected owner to housing relocation services for tenants displaced by the emergency. Alex Otthofer requested contact information of owner to reach business owner to offer resources.

Luis Ortega reported that Tenfold received \$150,000 in funding to support the Housing Location Services program through PHFA PHARE program. Mr. Ortega reported that the committee discussed House to Home Program guidelines to ensure the program creates affordable home buyer opportunities.

• Parks and Public Realm

Jake Thorsen updated the group on the Pocket Park and Juneteenth Event

Jordan and Shelby Wormely updated the board on the Artful Intersection project. The committee was successful in advocating to create parking – there will be a net 1 gain for the neighborhood. Engagement survey for community feedback resulted in 130 responses – 60% were from cabbage hill neighborhood. Three engagement session – 100 plus total individuals attend event

- 4. Directors Report
 - a. SoWe Community Survey

SoWe Community Survey set to launch in mid-august and run through the end of November. SoWe needs to get 300 survey respondents. SoWe will be partnering with Millersville University to conduct door knocking to obtain responses.

b. Funding Proposals/announcements

Jake Thorsen stated that Tenfold has applied to the Department of Community and Economic Development for funding to support housing rehabilitation in SoWe. Tenfold also received funding from PHFA's PHARE program to support Housing Location Services in SoWe.

Dean Evans introduced himself as a resident and member of the Traffic Commission. The board discussed several traffic areas of concern.

1. National Night Out Report Out

Committee discussed National Night Out. Police were out on bikes as part of their intentional outreach. Long term relationships cultivated, and new relationships were formed with SoWe as well as first response. Over 100 people attended the event.

2. Community Survey and Participant Survey

Jake Thorsen updated the group on the SoWe Community survey. Committee discussed the continuation of SoWe after the Wells Fargo Regional Foundation grant is completed.

3. Porch Light Marketing Targeted

SoWe has done intentional outreach for porch lights on key blocks. Post cards were sent to 400-600 block of Lafayette St properties and the 200 block of W. Vine Properties.

4. Bicycle Ambassador Report

David Aichele reported that an Outreach Worker hired last Monday. Outreach Worker is tasked with connecting the unhoused population with housing. She will cover the same footprint as the Ambassadors which includes SoWe.

5. Police Data Reporting

Two categories higher than last year - overdoses and shots fired. Other numbers are consistent or lower than the previous years. Shots fired is at 35 in 2021 as compared to 28 total in 2019
